

Obligations and warnings for drivers and operators of moving machinery:

The provisions of the Road Traffic Act, as amended, apply to operating on roads.

In addition, the following notifications apply:

- Roads where road vehicles can be operated are marked with letters and numbers on vertical signs at the intersections
- Any intersections without a right-of-way sign are intersections of roads of the same class and vehicles coming from the right have the right-of-way
- The maximum speed on the grounds is 40 km/h
- The maximum permitted vehicle or equipment height is 4.0 m
- Railway crossings do not have distance signs

And the following obligations:

- Do not park vehicles or machines under pipe bridges or within 3 metres of hydrants
- Give way to all vehicles on the road which you are entering when leaving a production facility, warehouse facility, or any other place off the road
- Ask the responsible manager for permission to enter buildings and production premises in a vehicle
- Follow any road traffic instructions from employees of the Fire Rescue Service, security agency, grounds guards, road administration and railway transport
- If you hear a siren stop your vehicle as close to the right hand side of the road as possible, turn off the engine, listen to the spoken message, and immediately follow any instructions. If the vehicle is in an accident zone where flammable or toxic gas is leaking place the keys to the vehicle on the seat and leave the vehicle and the risk area perpendicularly to the direction of the wind. For any other accident, leave the risk area by driving the vehicle away from the accident

Obligations of all those on the premises:

- Show a valid document when entering the grounds, authorising you to enter on foot or by vehicle
- Respect safety and traffic signs, information and notification boards, warning signals and instructions of the sound system on the grounds, and if an accident occurs, also any instructions of the operating staff
- Use only designated roads and paths for walking and driving
- Report to the responsible manager immediately when entering the facility or arriving at the destination
- Do not enter any facilities or premises where you are not working
- Request a written permit for each job in advance and do not commence any activity without it
- Do not enter the factory railway area
- Do not enter any areas that are below ground level
- Keep everything neat and clean and respect the environment
- Do not use electronic devices, including mobile telephones, in areas where an explosion might occur
- Follow the instructions of the Fire Rescue Service staff, security agency staff, and those authorised to carry out checks - they will show you an identification document with a grey strip - and prove your identity when requested
- Report any extraordinary event - injury, traffic accident, industrial accident, etc., to the company's dispatching on telephones 476 163 111, 476 162 111 or local extensions 3111 and 2111

Warning for all those on the premises:

If you breach any of these rules you may be prohibited from entering the grounds, either on foot or in a vehicle. Security agency employees in uniform and those carrying identification documents with a grey stripe may check to make sure you keep to these rules.



Safety Instructions for Being and Driving

on the Chempark Záluží Grounds Premises

Basic obligations and rules for all those on the Chempark Záluží Grounds:

- Do not start any work without a valid permit
- Do not use music reproducing devices with headphones
- Smoking is prohibited throughout the entire facility
- Do not handle equipment without authorisation
- Do not enter under the influence of alcohol or addictive substances
- Do not bring or use alcohol and addictive substances
- Do not bring firearms and explosives
- No photography and filming
- No entry to persons under 15 years of age, except on supervised site visits
- Do not bring animals

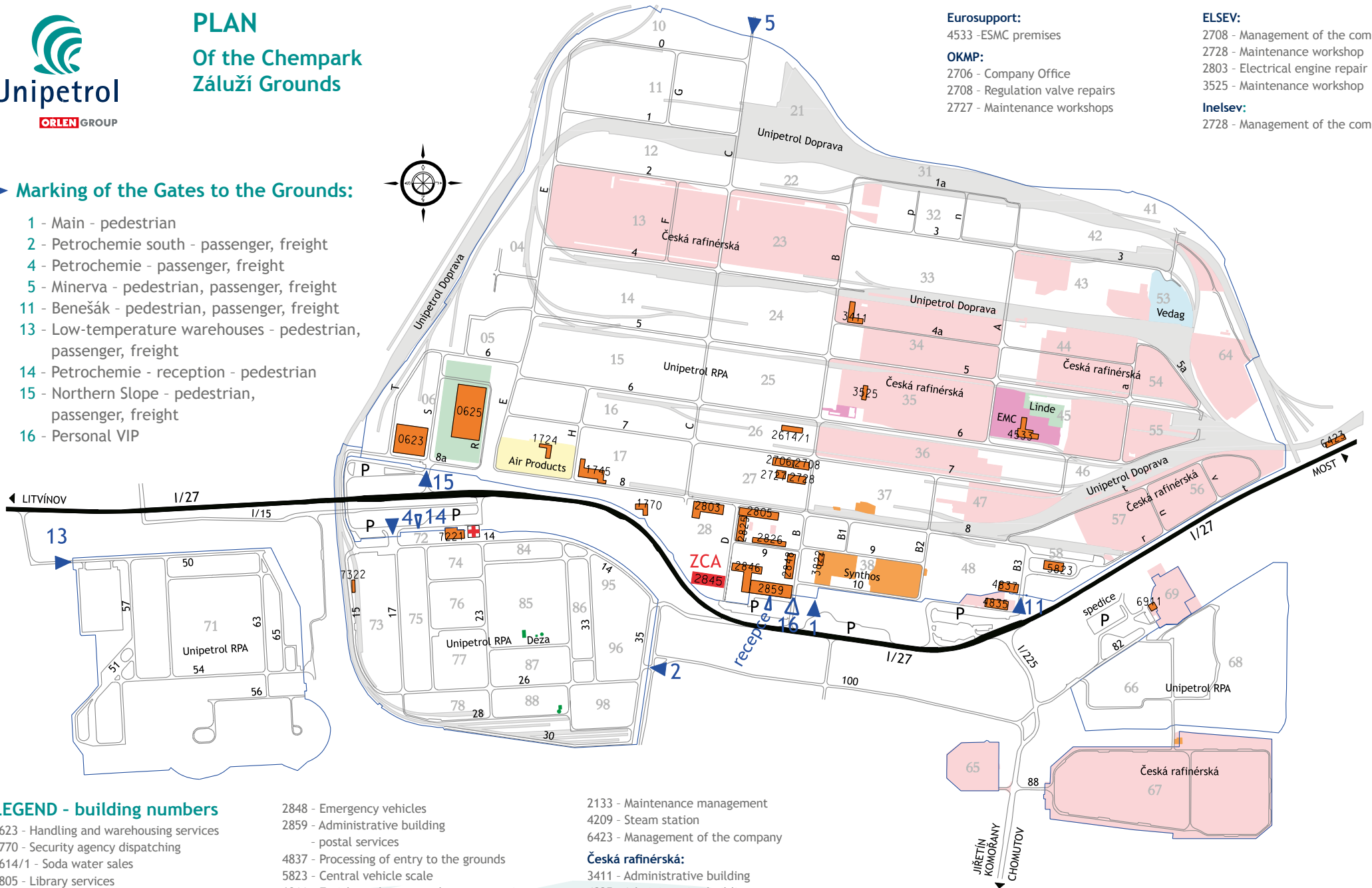
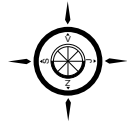
